Please find enclosed evidence to add to what has already been submitted, since 20 January 2022, in regard to the above incident number. This is all new information which has come to light since my last communication with yourselves and more recently with The Lord Advocate, Rt Hon Dorothy Bain QC. Listed is evidence of Medical Fraud and Medical Negligence in regard to Covid-19 Vaccines.

- (1) **30 April 2021** – Pfizer’s POST-AUTHORIZATION ADVERSE EVENT REPORTS, Worldwide Safety report Approved.

Appendix 1. LIST OF ADVERSE EVENTS OF SPECIAL INTEREST is six pages long and lists hundreds of adverse events to be expected from its Covid-19 Vaccine drug product including:

“Cardiac arrest”, “COVID-19 pneumonia”, “Facial paralysis”, “Vagus nerve Paralysis” (lots of paralysis) “Genital herpes zoster”, “Guillain-Barre Syndrome”, “Liver injury” “Chronic respiratory syndrome” and a plethora of Autoimmune diseases. Of particular interest is on page 12 in Table 6. Description of Missing Information. In the ‘Description’ column it states:

- Pregnancy outcomes for the 270 pregnancies were reported as spontaneous abortion (23), outcome pending (5), premature birth with neonatal death, spontaneous abortion with intrauterine death (2 each), spontaneous abortion with neonatal death, and normal outcome (1 each). **No outcome was provided for 238 pregnancies**” (see enclosed report by Pfizer).

- (2) **9 October 2022**, Health Correspondent, Helen McArdle, reported in *The Herald* this staggering admission of a dereliction of duty by health professionals in Scotland in respect to pregnant women, “Public Health experts ruled out any link between spikes in neonatal deaths and the Covid vaccine **without checking whether any of the infants' mothers had received the jag during pregnancy.**”

- (3) **10 October 2022**, Pfizer Exec, Janine Small was asked, by Dutch MEP, Robert Roos in the EU parliament: *“Was the Covid Pfizer vaccine tested on stopping the transmission of the virus before it entered the market.”* Janine Small’s answer: *“No. We really had to move at the Speed of Science”*. 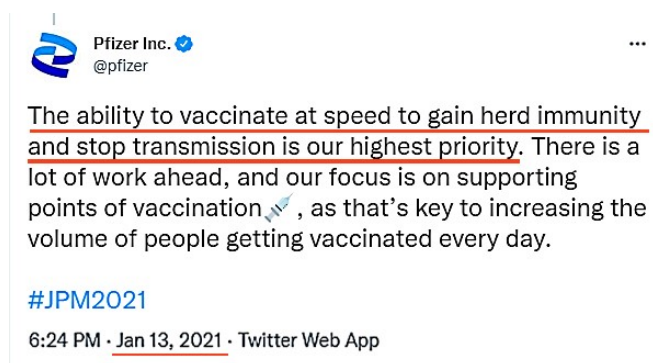
Small’s answer does concur with the Short Title of Pfizer’s Phase 1,2,3 Clinical trials, which is *A Phase 1/2/3 Study to Evaluate the Safety, Tolerability, Immunogenicity, and Efficacy of RNA Vaccine Candidates Against COVID-19 in Healthy Individuals*). The intention of the study is stated clearly on page 9, “This study is intended to investigate the safety, immunogenicity, and efficacy of these prophylactic BNT162 vaccines against COVID-19.” There is no mention of investigating the BNT162 vaccines against transmission.

The scandal which has occurred in Scotland is that the general public (the vast majority of whom trust the NHS, Scottish Government advisors and pharmaceutical companies implicitly) was led to believe the vaccines did reduce transmission. Parents believed the “safe and effective” mantra, and they were under the misconception that being injected with covid-19 pharmaceutical drug products would stop their children transmitting a virus to their grandparents. Here are a few examples of how these misconceptions came about.

Deception (i) exhibit - Pfizer Inc. (13 Jan 2021 on Twitter): *“The ability to vaccinate at speed to gain herd immunity and stop transmission is our highest priority.”*

Deception (ii) exhibit - Jason Leitch, Scotland’s National Clinical Director (27 Aug 2021) : *“But vaccination is the single most important protection against serious disease and harm, and increasingly we think, against transmission.”*

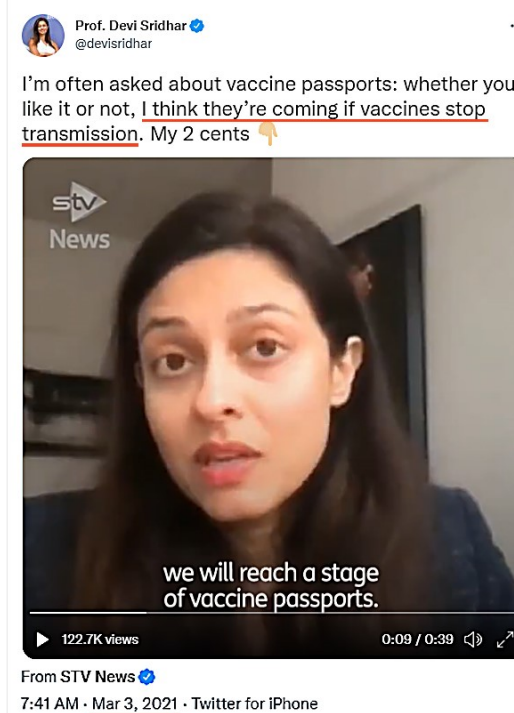

Prof. Devi Sridhar said this on STV News (3 March 2021) **example of media sharing her deception:**



- (4) **12 October 2022**, *The Courier* reported a death inside a vaccination in Forfar. The article states, “*It is not known if the man was there for a vaccine*”. Surely vaccines are nearly always by appointment, so it would be a fairly simple matter to check if the 76-year-old man was there for a vaccine or not. The article also states, “*The death is not believed to be suspicious.*”

Did the police interview all witnessed present to verify whether the man had, or had not been, been vaccinated on the premises? Without a post-mortem, how do the police know those working in the centre are telling the truth when it is natural to lie in order to avoid prosecution?

- (5) **Centers for Disease Control (CDC) RAW V-SAFE DATA (of Vaccine Adverse Health Impacts)**.

The CDC created V-SAFE, a smartphone-based program, to collect health assessments after Covid-19 vaccination. Approximately 10 million people signed-up and submitted health reports after Covid-19 vaccination. The legal team of ICAN (Informed Consent Action Network) sued the CDC twice leading to a court order requiring release of the data. ICAN has taken the CDC’s official raw V-SAFE data and created a dashboard interface which allows users to graphically view the 144+ million Vaccine Adverse Health Impacts entries obtained by ICAN involving all brands of covid vaccines. <https://www.icandecide.org/v-safe-data/> (see graph attached).

While this data has been collected in the United States, the same Pharmaceutical drug products are being administered into arms in Scotland, therefore it is relevant to look at this to decide whether these COVID-19 Vaccines really are as “safe and effective” as politicians, government advisors and NHS professionals claim them to be.

- (6) **International Journal of Vaccine Theory, Practice, and Research** – Analysis on the Blood of 1,006 Symptomatic Persons after Anti-COVID mRNA Injections from Pfizer/BioNtech or Moderna. (copy of published paper enclosed).
- (7) **14 October 2022**, 37-year-old John Watt from Glasgow (left bed-ridden since his 3rd Pfizer shot 10 months ago) recorded the script read out to him when he called the *Scottish Vaccination Help Line*. The full telephone call can be listened to here: <https://www.bitchute.com/video/3lu4stzzNaPM>. The video, on Bitchute is titled, **VAXX DAMAGED JOHN WATT RINGS THE SCOTTISH VACCINATION HELP LINE**.

The verbal script read out to John by an employee called Connor is **deceptive** in the extreme in regard to the true risks involved. The current ‘Side effects of the coronavirus vaccines’ described on the NHS Inform website (which Jason Leitch refers people to) is equally **deceptive** <https://www.nhsinform.scot/covid-19-vaccine/side-effects-of-the-coronavirus-vaccines> and **there’s no mention anywhere that participants would be taking part in Phase 3 drug trials.**

In light of the damning evidence as to the safety (and legitimacy of claims being made surrounding Covid-19 vaccines), it is imperative Police Scotland contact NHS Scotland **immediately to ensure participants are offered up-to-date information to enable them to give true INFORMED CONSENT prior to being injected.** Specifically, are adults, adolescents, parents and expectant mothers being informed:

1. **they (or their child) are taking part in a clinical trial due to finish in 2023-2024?**
2. **the Pfizer covid vaccine was not tested on stopping transmission?**
3. **the official infection fatality rates from covid-19 as the only cause of death on death certificates within Scotland for their age group?**
4. **the possibility of getting myocarditis or pericarditis in the case of youth and children?**
5. **the possibility of covid vaccines negatively interfering with other medication or vaccines?**
6. **the existence of an official system of reporting vaccine adverse reactions within the UK Gov. Yellow Card Reporting scheme which any recipient can and should access in case of suffering injury or having someone close to them suffering vaccine injury or even death?**
7. **the exact number of deaths and adverse effects for the brand of vaccine they will receive, as published in the most recent weekly reports of MHRA and therefore; the fact that there is a possibility of death or severe permanent injury following vaccination?**
8. **the possibility of having a severe, potentially life-threatening allergic reaction to any of the components of the vaccine as people have not been previously tested for sensitivity, according to recorded Yellow Cards data?**
9. **the maximum payment they can receive from the UK government Vaccine Damage Payment scheme is £120,000 should it go wrong? And to receive this payment requires proof of 60% disability caused and that a doctor has to verify the injuries are vaccine-related?**

Due to the seriousness of the situation a copy of this evidence has also been sent to The Lord Advocate Rt Hon Dorothy Bain QC.

Please provide me with a progression update of what inquiries you have made to date in relation to incident report 20220120-1333?
